



Colorado County Row Crop Committee
Scholarship

Scholarships will be awarded to a Colorado County graduating senior attending one of the high schools in Colorado County or a Colorado County Home School group. Decisions on the number of scholarships and scholarship amounts awarded are at the committee's discretion.

2024 Applications are due at the Colorado County Extension Office on
Monday, April 15th

To qualify for these scholarships the following minimum guidelines must be met.

1. Applicants must fill out the application form completely.
2. Applicants may choose any field of advanced education above high school level, including a 4 year or 2 year college or university or a technical school.

Selection Process

1. The Colorado County Row Crop Committee will screen applications and make the selections.
2. Selections will be made prior to the end of the school year and those selected will be notified as soon as the selections are made. Presentations will be made at the school's Award's Program or Scholarship Banquet.
3. Proof of registration to a school of advanced learning will be required before scholarship is awarded.
4. If the scholarship is not claimed by December 31st of the year it is awarded, it will become null and void, unless arrangements are made by the person receiving the scholarship.
5. Preference will be given to students pursuing a degree in a field related to agriculture or natural resources, students with a background in agriculture, and those with a true financial need.
