- I. **ESTABLISH A QUORUM & CALL MEETING TO ORDER** President Steve Williams called the meeting to order at 6:00pm. All Board members were present.
- II. **PLEDGES** The U. S. Pledge of Allegiance and the Texas Pledge, led by 4<sup>th</sup> Graders Paisley Pesak and Tucker Bouse, were recited.
- III. **INVOCATION** Superintendent Chase Seelke led the invocation.
- IV. **RECOGNITIONS / CELEBRATIONS** High School Principal Stacy Heger introduced the following students which were commended by the Board and visitors present:
