Use of Funds

\$913,695 ESSER III Funds

- At least 20% of funds, must be spent on learning loss mitigation.
 - Reading & Math Interventionist, SEL Coordinator/Counselor
- Purchasing supplies to sanitize and clean facilities
- Purchasing educational technology that aids educational interaction between students and teachers.
 - Interactive TV's
 - Teacher Laptops
- Providing mental health services and support
 - WJH School Counselor
 - 2021-2024
- Addressing learning loss among students.
 - WES Math and Reading Interventionist
 - 2021-2024
- Improve indoor air quality
 - WJH & WES air conditioning units
- Planning and implementing online learning (change to Other activities necessary to continuing to employ staff of the LEA)
 - COVID Teacher Stipends 20-21
 - Employee Stipends 23-24

COVID Teacher Stipends (20-21 SY) Employee Stipends (2023-2024 SY)	\$63,552.73
